Solid Waste Convenience Site Update

Closed Potts Spring on 10/26 Closed Gigg on 10/30 Closed Courthouse site to public after business hours on 10/30

No waste deposited at the Beaver Creek sites since putting up boundary tape. Removed cans from Courthouse site on weekend and had no waste deposited. On weeknights, people are walking around the chain gate and depositing waste in the receptacle. It was overflowing by Wednesday midday.

Switchback and Oral Oaks closed at 7pm starting November 1st and reopen at 7am.

We have one open-top can at each site for items that are not able to be put in the compactor.

Bulky item loads must be taken to the Landfill.

Landfill hours are Monday through Friday from 7am - 4:30pm and Saturday from 7am-2pm. They have a walk-through in the main gate for those who want to dispose of household waste after they close.

They are not asking citizens to take bulky items to the tipper, only to open top cans at the edge of the blacktop across from the scale. Commercial waste must be taken up to the tipper.

They are charging for trailer loads. Brush is free, unless it is from a business. There is a cost for tires, mattresses, and other bulky items. I have reached out to Tim Webb regarding certain items and how they are charged. I hope to update you at the meeting.

Looking for 2-4 acres in Beaver Creek District to locate a new convenience site.

Researching options for the Courthouse, but one option is to close it to the public completely by placing locked receptacles and permanent gates at the site. This would be the most cost-efficient option. Placing a compactor will require manning the site. Construction would be about \$65,000, plus the cost of labor to man the site.

Dear County Administrator:

The Department of Motor Vehicles sells the Animal Friendly license plate, which is authorized by Virginia Code, §46.2-749.2:7, as part of its special license plate program. This plate is issued to supporters of dog and cat sterilization programs at a cost of \$25.00 per year in addition to the prescribed fee for vehicle registration. After the first 1,000 sets of plates are sold, \$15.00 of each fee is made available to the locality in which the vehicle is registered, to be used to support sterilization programs for dogs and cats. This money is set aside in a special fund titled the Dog and Cat Sterilization Fund for distribution to localities, regardless of the amount of funds involved. For Fiscal Year 2020, DMV's records indicate that your locality is due \$90.00 from this Fund.

Virginia Code §46.2-749.2:7 requires each locality to certify that this money will be used to support sterilization of dogs and cats. If your locality does not have a program for this purpose, the statute provides the locality options. You may make the funds available to any private, nonprofit sterilization program for dogs and cats in your locality or decline receipt of funds. Any funds that are declined shall be distributed to other affected localities on a pro rata basis.

Attached to this letter is a form to make your choice pertaining to the amount stated above. Complete the form and return it no later than December 11, 2020, to:

It is about 6-7 hours per week of work and I am happy to say I will finish at 100%.

happening.

- There was an election security meeting with a potential vendor, but I could not attend as I was under self-monitoring for possible COVID-19 exposure. Rob Williams from DataCare, our IT professional, attended. He also answered a list of questions for the Electoral Board Chair regarding IT concerns.

Airport

Mowing has slowed at the Airport.

No progress has been made on funding for the runway at the state level.

Budget & Finance-

- Handled over 20 email correspondence for the VA Public School Authority bond application and subsequent signatures on paperwork. The wire will be issued 11/6 and closing shortly thereafter.
- Commissioner Hamlett contacted me regarding cigarette stamps and whether the Board has interest in implementing the tax. I am including some information behind my report.

Building Official and Building & Grounds -

- Word's Construction completed work on the Clerk's Office.

 Jamie Tuck obtained quotes for the generators for Administration and Treasurer and Root Electrical will be doing the work. There is a shortage of generators, so hoping they will be here and installed in time.

- The roof at the Sheriff's Office is not leaking so far. Inside repairs will take place soon.

- We have a catastrophic electrical failure in one of the elevators in the old Courthouse. The quote is \$45,000! They believe it short-circuited due to the basement flooding during all the rain and Nicole is contacting our insurance carrier.

Community/Economic Development/Planning -

- Glenn and I met to discuss his plans concerning county-wide internet initiatives and I gave him some contacts to start his research.
- Participated in joint solar worksession with the Planning Commission.

 Attended Planning Commission meeting to discuss the solid waste Meridian C.U.P. revision to match the wording to the Host Agreement for acceptance of citizen waste in personal vehicles.

 Contacted the old Lunenburg High School Alumni to request a date for a ceremony for the Civil Rights in Education Heritage Trail sign at the "Lunenburg High School" location on K-V Road.

Exchanged emails and a phone call with Lee Smyth regarding a request for IDA funding of a project in Victoria. The Victoria IDA is taking up the project request.

Exchanged emails with the Tobacco Commission regarding the Coast 2 Coast Trucking grant repayment. They are working out an agreement.

COVID-19 Updates -

- CARES Act Funds I submitted the second quarterly financial report for CARES funds on 10/5.
- I also need to submit a grant compliance survey by 11/9.
- The first round of Small Business Grants went out in October. We have not had much time to work with the applications for the second round, but we will utilize our PT Emergency help to get these done in a timely fashion.
- First Lunenburg COVID-19 case was April 6th, the total VDH count as of 11/4/20 is one hundred fifty-five (155), not considering recoveries. I no longer have an accurate count on recoveries. We have had 8 hospitalizations and 4 deaths.
- We are still seeking a solution for the courtrooms to allow for up to 50 potential jurors to be in place at one time.
- I am participating (as I can) in a district-wide weekly call with VDH and School reps to discuss progress in vaccine availability and information for school-age cases.
- The Governor's Health Equity initiative has resulted in a grant opportunity for Lunenburg through VDEM, but we must have a plan for expenditure of the 50/50 funds by Nov. 9th.
- Our part-time staff member has helped us get caught up with COVID-related items and other things that needed done due to the attention we have had to place on COVID-19. We are still behind, but making progress.

Emergency Management & Public Safety -

- Submitted special condition paperwork to DCJS for School Resource Officer and the

requirements are much more stringent.

- The Sheriff's Office lost their long-time Administrative Office Manager this week to a new job opportunity.

Piedmont Regional Jail Authority and Juvenile Detention Center Board -

- I received the paperwork requesting funds for deep cleaning and replacing some items unable to be cleaned properly due to age and wear from the Jail. I will run it by the committee first.

Schools

- Received a response letter from the School Board Chair regarding staff attendance at the Board of Supervisors meetings. I put a copy in your school section.

Social Services and Children's Services -

- I worked with CSA Program Coordinator Bridgette Malsbury is on maternity leave and other staff is on quarantine in the Family Services Unit. We will be delayed on reporting, but the State is on notice and is working with us.
- Held an electronic DSS Advisory Board meeting.
- Held a meeting with the Unit Supervisors and Dotty to go over statistical data from the State and operational items/needs.

Solid Waste -

- Held a Recycling Day with Meridian Waste staff on Saturday, October 10th. We had about 5 guests come to recycle, and with the awful weather, we felt it was not a total loss. Talked with Joe Gustaf and Misty Grant of Meridian during the event about operations in Lunenburg.
- Implemented county-wide manned sites all hours and reduced overnight hours at the two 24/7 sites. We are fielding a lot of questions and complaints, but most people are understanding. We have not had to pick up stray waste at our two closed sites in Beaver Creek.
- Jamie and I met with Jeff Robinson to discuss plans for the CH Site.
- Filed paperwork for the Litter Grant with DEQ. Have one item for follow-up.
- Held a staff meeting with all Solid Waste workers to go over new procedures and changes in hours. They had lots of good questions and input. We have taken quite a few of their suggestions and implemented them, especially safety requests.
